## RULES AND REGULATIONS

**STARTING TIME** - The Parade will begin at 10 am except in the event of bad weather. A decision will be made at that time as to whether the event will be delayed or canceled, without rescheduling.

**PARTICIPATION** – No items of ANY KIND can be tossed or thrown during the parade. The Laurel County Homecoming, the City of London, and Laurel County or its officials, shall not be liable, or held responsible for any personal injury, or damage or loss to parade entries or observers, or responsible for any loss incurred due to accidents before, during or after the parade. Your entry in the parade implies this waiver of liability is understood.

**NO SIRENS, HORNS OR WHISTLES ARE TO BE USED DURING THE PARADE. YOUR COOPERATION IS APPRECIATED.**

**LINEUP**—9:00am Saturday Aug 20th at the Vendors Mall parking lot.

**MOVEMENT** – No stopping permitted unless an emergency. To avoid breakdown of parade, all units shall maintain a distance of 30 feet from the unit ahead. Please allow this distance between entries so the parade will not be a “bumper to bumper” situation.

**LIMITED ENTRIES** – In the interest of safety to spectators along the parade route, no unlicensed or unauthorized vehicles (mopeds, motorcycles, two-three-or-four wheelers, dune buggies, mini-bikes, go karts), in-line skates, or other entries of questionable nature, in the judgment of officials, will be allowed. Horses are allowed IF they are diapered or are followed by a designated street cleaner supplied by the horse's owner. Skaters or skateboarders can only participate in the parade by being an extended part of a float.

**ADVERTISING** – Business advertising is limited to float entries and candidates. The Laurel County Homecoming does not get involved in any active political campaigning. If you are a candidate running for political office, the only sign that can be displayed on your vehicle/float may state your name and the political office. There will be NO active campaigning along the parade route. Nothing can be thrown from the vehicle/float or handed out to spectators for campaigning purposes at any time during the parade.
