**FEES:** Entry fee is \$50.00. A sibling discount will be offered, which will be \$5.00 off each additional child. Deadline for entry is **Tuesday, July 29th, 2025** at 7 p.m. No exceptions. **For any additional information, call or text Taylor Sivley at (865) 296-0963. Payment by Cash or Check. ALL CONTESTANTS MUST BE A RESIDENT OF LAUREL COUNTY, KENTUCKY. \*\*TWO (2) forms of proof must be included with paperwork. One form of ID must be a valid Kentucky Driver's License. Another form of ID can be a utility bill or phone bill.\*\***

**SAVE THE DATE:** Information session will be held at Levi Jackson Clubhouse on July 12th from 4-5 pm. During this session, you will learn more about the Little Miss & Masters LCH pageant. I will also answer any questions you may have concerning the pageant and parade.

**THEME WEAR:** This portion of the pageant is included in the entry fee. Introducing this year's theme: **"The Greatest Show" 90 Years Under The Moonlight. This portion of the pageant will kick start the pageant as each contestant is encouraged to participate.** The event will start in the theme wear category of the pageant, **you're encouraged to wear your Theme wear attire if participating in the parade.** The Miss & Teen LCH contestants have a traditional portion of the pageant dedicated to theme wear, contestants wear an outfit depicting their vision of the theme, this year's theme is: **"The Greatest Show"**. There is only one Theme Wear awarded for ages 0-12.

**FORMAL WEAR:** This is included in the entry fee. Formal Wear attire can be a store-bought pageant dress, flower girl style dress, or dressy Sunday Best. Those ages 6 and older should have a floor length dress. Dresses must be age appropriate and can have beading/embellishments. **NO CUSTOM** dresses. **MAKEUP** should be kept to a minimum. This is a **“NATURAL PAGEANT”**. No hairpieces or flippers allowed. Boys may compete in Tuxedo or Sunday Best.

**PHOTOGENIC:** This portion of the pageant is included in the entry fee. Photos must be 8x10. **Photos** can be color or black & white. **Contestant NAME & CATEGORY must be on the back of all photos submitted.** **NO FRAMED ENTRIES.** The official headshot photographer is Felicia AuBuchon Photographer. She will be providing each contestant with a digital pageant headshot. It is the contestant's responsibility to schedule an appointment with Felicia. The photos will take place at her studio and each contestant will be able to choose which image they want to select for their headshot. She can also print and frame them for you for a \$20.00 fee. This will be the photo displayed in the Silver Spoon Formals window on Main Street, Sentinel-Echo, Facebook and Instagram. Once submitted these cannot be changed. One digital image will be provided by Felicia but you may choose to purchase others. Headshots are due for submission no later than July 31st. It's the contestant's responsibility to pick up **framed** headshot from Silver Spoon and contestants can pick up **unframed** photogenic pictures after the pageant concludes. There is only one Photogenic awarded for ages 0-12.

**PEOPLE'S CHOICE:** This category offers the contestant an opportunity to win an additional award. Contestants **MUST** submit 1 color photograph via email to [chelsea@laurelcountyhomecoming.com](mailto:chelsea@laurelcountyhomecoming.com) along with Contestant Name and Category. The first week of August they will be uploaded to our website: [www.laurelcountyhomecoming.com](http://www.laurelcountyhomecoming.com). Family and friends will then be able to vote for their favorite contestant. Votes are \$1 per vote. They pay via PayPal for their votes (multiple votes from one individual can be submitted at a time such as \$25.00 submission will give the contestant 25 votes. There is only one People's choice awarded for ages 0-12.

**JUDGING:** The decision of the judges is final. Each contestant will be given the same criteria.

**GOOD SPORTSMANSHIP:** It is HIGHLY important that you and the participant(s) understand that there is only ONE crown per age division. We are here to encourage the children to do their best. As long as they try hard, they are successful. Our pageant is run as fair as humanly possible. 2024 title winners may not compete in the same division for the 2025 title.

**HOMECOMING PARADE:** Each contestant may participate in the annual “Homecoming Parade”. It will be held Saturday morning (August 9th) at 11:00 AM. This year's parade will be focused around Town Center Park. You must provide your own transportation during the parade. It can be a car, truck, float, etc. Contestants are encouraged to wear their **Theme wear** attire that they are competing in so when the parade concludes, contestants will be prepared for the pageant to begin at 12:30 pm.
